1. DESCRIPTION OF WOMEN'S EMPOWERMENT ACTIVITIES

1.1 Summary Description of the Women's Empowerment Activities Implemented

a) The location of the Project.

The project is implemented in Manoka, an island located in the coastal region of Cameroon, in the Douala Vith(6th) district where fishery sector is the main source of income for the population. The main activities of the population is fishing, fish sales and smoking. Manoka is divided into fishing camps. Among them, Dahomey, Plateau, Sandje, Nyangadou are the locations where fish smoking is the main women's activity.

b) *Conditions prior to the project's implementation*

With a surface of 232,723 ha (Cam-Eco, 2014), Cameroon's mangrove ecosystems are among the largest in Africa thus, ranked 6th worldwide (UNEP, 2007). The coastal communities rely heavily on mangrove forests for construction and fuel wood for cooking and smoking fish.

The traditional fish smoker used by women is a simple wooden structure with a grid on which the fish are placed. The sides of the smokers are opened. The traditional fish smoking is heat drying and smoking process. With the traditional smokers, there is no temperature control or control of the smoke produced. This system requires a massive burning of wood which leads to other constraints such as deteriorating women's health. In Manoka, women spend their days smoking fish in rudimentary smokers. Aside from the long hours they spent in the smokehouse, which leave them sleepless, no time for other activities, whether reproductive or productive, they are also exposed to a number of risks. Women have a health burden from fish smoking, they complain of respiratory distress, burning eyes. Many of them have experienced skin burns.

Moreover, this traditional system does not enable control over smoke production and fire temperature. It involves the use of fuelwood more than necessary, which can lead to forest depletion.

c) *A description of the W+ domain(s) and activities/measures to be implemented by the Project.*

Time saving

The aim of implementing the improved fish smoking models is to contribute for the restoration of the mangrove by reducing the amount of wood used for smoking fish. Not only is the quantity of wood reduced, but the smoking time has also been greatly reduced.

Compared to the traditional systems, using the improved models saves time for women's users. The smoking time for 30 kg of "Bonga" fish was estimated at 22 hours on average using the traditional fish smoker. The time for smoking the same quantity of fish with the improved stove made with clay bricks is shorter (19h on average), i.e. a saving of four hours (18.2% time saving). Time saved using the metallic fish smoke model is more than this.



The time for wood collection is also reduced. Women are the ones who collect the wood they need for drying fish. They took the wood in the mangrove forest. For that, they go usually once or twice a week, in a group of 4-5 women using the boat, cut and leave the trees there. For collecting the wood, either they go back in the site where they cut the trees or pay their husband or someone else to collect the wood.

Income & Assets

Increased income is mainly due to reduced cost price, (1) reduced quantity of wood and (2) reduced time of drying.

With the improved fish smoking models, the quantity of wood is reduced by 36,36% compared to that of traditional ones. Related expenses to wood collection are the engine coast for the boat, payment of workers who collect the wood. The improved fish smokers promote fast drying and need less wood.

For the time being, women said that the smoked fish price remains the same for that smoked in traditional and the improved stove even if the quality is not the same. Compared to that from the traditional stove, fish smoked with the improved stove is an attractive color (golden color) and appearance, better flesh texture, and easy to transport without too much breakages.

One fish buyer in Dahomey said that there are different clients of the two types of fish (from traditional and improved stoves). The dried fish from improved fish smoking models are in much greater demand in the cities like Douala, Edea and Yaounde.

1.2 Project Sector(s) and Type(s)

This is an energy efficiency sector in fish smoking. The improved technology enables women fish processors to improve their income and health. It also helps to reduce the time spent in fish smoking. The W+ project will measure income and time saved generated through the implementation of improved fish smoking technology in Manoka, Cameroun .

1.7 Description of the Project's Activities

A study carried out by CIFOR in collaboration with Cameroon Ecology and REFACOF highlighted some shortcomings in the legal and institutional framework; and assessing the mangrove wood energy supply chain revealed (1) the lack of organization and structuring of actors along the supply chain; and (2) the excessive and unsustainable cutting of the forest resource.

Results of this study led to other initiatives aimed at minimizing the negative impacts of mangrove wood exploitation in Manoka. These included reducing mangrove fuelwood demand, improving energy efficiency and women's health while increasing their income.

Income & Assets

Implementation of three improved fish smokers, two metallics and one made with clay brick in Dahomey and Nyangadou. For an efficient use of the improved fish smokers, trainings of AFUMA's (Association des Femmes Fumeuses de Manoka) members were organized.

Time saving

The shorter processing times with the improved fish processing technology frees up time for households and leisure activities and rest.

1.8 Project's Activities Boundary and Scope

The target group of beneficiaries are women fish smokers who practice this activity as their main and only source of income. They are in majority the fishermen's wives.

The project is implemented in Manoka, an island located in the Littoral region and Wouri Division in Cameroon, between 3°51'19"N and 9°36'53"E. The site is subdivided into camps. Fish smoking is practiced by women mainly in Nyangadou, Dahomey, Sandje and Plateau camps.

As a pilot program, two improved fish smoking models, one made with clay bricks and two metallic, aiming at reducing pressure of mangrove wood, by improving the energy efficiency of fish smoking through limiting heat loss and smoke, were setting up by the project.

This initiative came along with a process of structuring and good policies, well structured. However, a very good and robust Implementation strategy should be considered. A good monitoring and evaluation strategy is also important for training women who smoke fish. The "AFUMA" association was therefore created for the objective to help unite the women and facilitate their business by promoting and adopting appropriate modern techniques. The association counts around 235 women smokers and most of them live in Dahomey and Nyangadou camps. Population is made up of different nationalities. Among them are Nigerians, Cameroonians, Malians and some Ghanaians.

The improved smoke systems were installed in camps with more women smokers, i.e. in Nyangadou and Dahomey. The clay bricks smokers and a metal oven were installed in Dahomey and the other metallic one in Nyangadou. These fish smokers were installed in AFUMA board members' kitchens.

1.9 Conditions Prior to the Project's Initiation of Activities

The majority population of Manoka depends on fishery sector for their livelihoods. The main activity of women in Manoka is fish processing. Prior to the implementation of the project, women smokers were suffering from health problems as a consequence of exposure to heat, to smoke and to sleepless. These women make extensive use of traditional smokehouses with at least 2 stoves in their kitchen to process the large quantity of fish, mainly during the peak season from November to March. Generally, women processors spend more time using the traditional smoke system. Smoked fish are sold to traders who resell them to different markets of large cities such as Yaounde and Douala or exported to Nigeria. Regarding the texture, fish flesh from traditional smokehouse are easy to crumble which impacts the price offered by the buyers.

Other impact of the use of traditional stoves includes the rapid depletion of the forest leading to environmental degradation as these models require large quantity of wood for smoking the fish. With the traditional processing technology, it is difficult to control the smoke and the temperature. It involves the use of wood more than necessary.

For their work in fish processing, women are considered as their husband's workers. They received 20% of the gross income from the sales of smoked fish. From that, they pay all the expenses related to their activities.

2. GENDER ANALYSIS

The interviews for gender and stakeholder analysis with a total of 51 women were held between 10 to 18 January 2024 in each of the 4 fish camps where the monitoring was conducted:

The results of the analysis are presented below. The consultations revealed an obvious gender trend in terms of activity profile. Women in Manoka take care of all activities related to fish smoking: participating in removing the fish from the net, transport fresh fish from the boat to the smoke house, placing and turning over or folding fish on the grill, while, men's work is around fishing.

Fish smoking activities vary considerably according to the weather conditions. Low season is from April to October and the peak season from November to March. The most important constraints highlighted by women fish smokers are their work burden and time poverty. During the peak season, women may stay in the smokehouse all day and night for fish smoking processing and they need more than one fish smokers per kitchen to facilitate the smoking. The improved technology could not cope with the large volumes of fresh land fish (called locally as bonga) landed during peak fish seasons.

The tables below show the extent of women's engagement in fish processing while men do the fishing and have time to rest in between. The money from smoked fish sales belongs to their husband who give them 20% back. Men pay for household's expenses like children care, food purchase, and healthcare.

If time allows, women have the responsibility to do most of the reproductive activities, household chores related to childcare, cleaning and food preparation, with little or no help from their husbands.

Community activities of women include participation in different meetings of village saving groups and training events organized at village levels. They also take part actively in celebration of important days like International Women's day, Unity Day, and Labor Day.

Time management

Time poverty

A significant time burden for women fish smokers arises from long hours processing of fish from removing the fish from fishing net, transporting the fish to the smokehouses and particularly the fish smoking. The traditional practice is labour-intensive, which places a significant time burden on women fish processors. During the peak season, men can fish 3 times a day.

Activities and time allocation for inside and outside activities vary with gender. There is a major disparity in time devoted by men and women for different activities. Time allocation also varied with seasonal variation.

Women work significantly longer hours than men. During peak season men work up to 14,5 hours a day and rest for 9.5 hours; whereas women work for 20 hours and rest only for 4 hours. Women spend less time for smoking fish during the low season and have a little more time to rest during this period.
